

ADDENDUM TO  
ST. JOSEPH CHARTER TOWNSHIP  
CONTRACT FOR  
RESIDENTIAL TRASH COLLECTION AND DISPOSAL  
(Including Recycling & Yard Waste Removal)  
April 1, 2025- March 31, 2030

This Addendum is entered into on this 1<sup>st</sup> day of April, 2025 by and between St. Joseph Charter Township (The "Township") and Best Way Disposal, Inc. ("Best Way"). It shall become a part of and be incorporated into the contract for Residential Trash Collection and Disposal which was executed by the parties and dated November 1, 2007 (The "Contract") shall remain the same.

**1. Renewal** The Parties agree to renew the contract for five years from April 1, 2025 to March 31, 2030.

**2. Rates:**

**Year 1:** For the Period April 1, 2025 through March 31, 2026, the rate per residential unit per month including biweekly recycling and weekly yard waste removal (April - the second full week of December). Shall be \$18.68 per unit.

**Year 2:** For the period April 1, 2026 through March 31, 2027, the rate per residential unit per month including biweekly recycling and weekly yard waste removal (April - the second full week of December). Shall be Year 1 rate + CPI-U or 4% whichever is less.

**Year 3:** For the period April 1, 2027 through March 31, 2028, the rate per residential unit per month including biweekly recycling and weekly yard waste removal (April - the second full week of December). Shall be Year 2 rate + CPI-U or 4% whichever is less.

**Year 4:** For the period April 1, 2028 through March 31, 2029, the rate per residential unit per month including biweekly recycling and weekly yard waste removal (April - the second full week of December). Shall be Year 3 rate + CPI-U or 4% whichever is less.

**Year 5:** For the period April 1, 2029 through March 31, 2030, the rate per residential unit per month including biweekly recycling and weekly yard waste removal (April - the second full week of December). Shall be Year 4 rate + CPI-U or 4% whichever is less.

**3. Recycling Services:** Best Way will provide 96-gallon recycling carts with every other week pick up to residents who elect to participate in the recycling program.

**4. Governmentally Mandated Fees:** Best Way reserves the right to modify the rates set forth in Paragraph 2 above during the extension period due to changes in any governmentally mandated fees, and the Township agrees that it shall pay the modified rate. Best Way will provide 30 days' notice prior to any changes.




