

CODE COMPARATIVE TABLE ORDINANCES

This table gives the location within this Code of those ordinances adopted since the 1984 Code, as updated through October 1, 2000, which are included herein. Ordinances adopted prior to such date were incorporated into the 1984 Code, as supplemented. Ordinances adopted since October 1, 2000, and not listed herein have been omitted as repealed, superseded or not of a general and permanent nature. The 1984 township Code consisted of ordinances adopted on the same date in a coherent format using ordinance numbers. Therefore, ordinances without adoption dates were part of the 1984 Code and ordinances with adoption dates are subsequent ordinances.
